This guide provides essential resources and tools to support practitioners, managers and agencies in addressing neglect within Manchester locality. It includes links to training materials, templates, and guidance documents to ensure effective implementation and monitoring.

Resources

Embed into practice

- **Group Supervision/Learning Circles** - Use the recorded presentation/video.
- **Neglect Champions** - Increase the number of neglect champions within your agency/team and ensure they attend quarterly champion events.
- **Performance Monitoring** - Map the use of the GCP2 tool and/or all-age neglect tool into team performance monitoring.
- **Record Keeping** - Maintain a record of how often your team completes the GCP2 tool and all-age neglect tool.
- **Case Supervision** - Utilise the all-age neglect tool and / or GCP2 to support professional curiosity during case supervision.
- **Training Access** - Ensure practitioners have accessed relevant MSP training on GCP2, child neglect, and adult neglect.
- **Family / Multi Agency Meetings** - Support practitioners to use the GCP2 tool at **Core Group** meetings, **Child In Need** Meetings, **Team Around the Family** Meetings for multi-agency working and information sharing.
- **Child Protection Conference** – For any child on a child protection plan with a category of neglect Chairs should ensure that GCP2 is tool is used to assess and demonstrate impact within the child's plan.
- **Referrals** - Utilise the all-age neglect tool to strengthen evidence for referrals into child and adult early help or adult MAPs (multi-agency prevention and support) meetings.

Review impact

- **Quality Assurance** - Conduct regular reviews of completed GCP2 tools and all-age neglect tools to ensure quality improvement. Provide feedback to MSP via neglect champions and agency representatives at the MSP neglect sub-group.
- **Data Review** - Analyse the number of completed GCP2 tools and all-age neglect tools. Identify trends, blockers, or gaps in the system and take necessary actions.
- **Feedback Mechanism**: Establish a clear process for collecting and acting on feedback from practitioners using the tools.
- **Continuous Improvement**: Implement a continuous improvement cycle to regularly review and refine the quality of the neglect tools being completed.
- **Impact Assessment**: Conduct periodic assessments to measure the impact of the neglect tools on case outcomes and practitioner performance
